CHECKLIST FOR VENDORS

FRESH BUCKS AT THE FARMERS MARKET



Pre-Season

- Fill out the Vendor Application. This will be emailed to you if you have not completed it and it is also available at freshbucksindy.org/get-involved.
- Submit a Vendor Technology Agreement if borrowing equipment.
- Review Fresh Bucks training materials provided. In-person training is available upon request by emailing FreshBucksIndy@marionhealth.org
- Pick up your Fresh Bucks binder from your market manager.
- Set up an ACH account with Epic Technology.
- Install the Fresh Incentives app on all devices that you will be using to complete Fresh Bucks transactions. This includes any device that may be used at any farmers market that you will be participating in. You can be logged in on up to six devices at a time.
- Set up your Fresh Incentives account. You will use the same account on all devices.
- Ensure that your information is up to date with your market. This includes what markets you will be selling at, addresses, phone number and email.

Every Market Day

- Bring Fresh Bucks vendor guide to market.
- Put up any Fresh Bucks signage that was provided to you.
- Ensure that your device is charged by charging the night before.
- Login to the Fresh Incentives app and select your market.

End of Season

- Fill out any vendor surveys requested. This will help us to improve the program.
- Return any borrowed materials.
- Check in with your market manager for any additional requirements.

STEPS TO COMPLETE A FRESH BUCKS TRANSACTION



SIGN IN



1. Locate the “FRESH INCENTIVES” application (carrot icon) on your device.
2. Enter your e-mail address and password.
3. Set your location to the farmers market you are currently at.

SPEND FRESH BUCKS



1. Click on “SPEND”.
2. Enter the \$ amount of “LOCAL PRODUCE” (Fresh Bucks eligible items only).
3. Click the ARROW (top right).
4. Scan Fresh Bucks card with camera or swipe if provided a card reader.
5. Press the CHECKMARK (top right).
6. Receipt Screen - Customers can enter their email address to receive an electronic copy of their receipt.
7. Press “SEND” to email customer. Complete Sale by pressing “OK”.

CHECK BALANCE



1. Press “BALANCE”.
2. Scan Fresh Bucks card with camera or swipe if provided a card reader.
3. Balance appears.
4. Press “OK”.

HISTORY & REPORTS



1. Click on “HISTORY”.
2. You will see transactions listed from newest to oldest.
3. You can click on an individual transaction to see more information.
4. To find daily totals click on the “TOTALS” tab.
5. Click on the tabs along the bottom to review detailed reports.

Note: This is the history of transaction for one day only. To view full history of transactions go to FreshIncentives.com and log in with your same credentials. The menu on the lefthand side has a “Reports” section. “Vendor Payout” will show all sales.

VOID THE LAST COMPLETED TRANSACTION



1. Select “HISTORY”
2. Click on the last transaction to view the receipt screen.
3. Press “VOID TRANSACTION”

FRESH BUCKS PROGRAM INFORMATION



How Fresh Bucks Works:

- Fresh Bucks is a SNAP matching program that helps people who use SNAP, known as Hoosier Works in Indiana, to purchase and eat more fruits and vegetables.
- Fresh Bucks is a triple win for customer, farmers, and the local economy.
- Only a SNAP/EBT card is required to be eligible to enroll in Fresh Bucks. Anyone who receives SNAP is automatically eligible for the program.
- Purchases with a SNAP/EBT card earn up to \$20 in Fresh Bucks each day at farmers markets.
- Fresh Bucks can be spent on fresh fruits, vegetables, and herbs, as well as plants that grow fruits, vegetables, and herbs.

Earning And Spending Fresh Bucks:

1. Click on "SPEND".
2. Enter the \$ amount of "LOCAL PRODUCE" (Fresh Bucks eligible items).
3. Click the ARROW (top right).
1. Scan Fresh Bucks card with camera or swipe if provided a card reader.
2. Press the CHECKMARK (top right).
3. Receipt Screen - Customers can enter their email address to receive an electronic copy of their receipt.
4. Press "SEND" to email customer. Complete Sale by pressing "OK".

Frequently Asked Customer Questions:

Q: Why are only certain sites participating in Fresh Bucks?

A: We are still growing the Fresh Bucks program and are excited to offer it at many farmers markets in Marion County. As the program grows, additional farmers markets and retail sites may be added.

Q: How can customers check their Fresh Bucks card balance?

A: The card balance can be found by creating an online account at MyFreshBucks.com. Once a shopper creates an account, they can log in and see their Fresh Bucks balance. Vendors and market managers can also check their balance by pressing "CHECK BALANCE" and then swiping the Fresh Buck card.

Q: What can a customer do if they lost their Fresh Bucks card?

A: Visit the market manager booth to get a new card. The shopper will need the same EBT card they enrolled in Fresh Bucks with to transfer any existing Fresh Bucks onto their new card. When a manager assigns you a new card, the old card will be invalidated. Any Fresh Bucks balance on the old card will be transferred to the new card.

Q: Does Fresh Bucks match WIC?

A: No, WIC purchases are not eligible for Fresh Bucks dollars.

Q: What if a shopper has an EBT card that is not connected to their Fresh Bucks card?

A: Refer shopper to the market information booth.

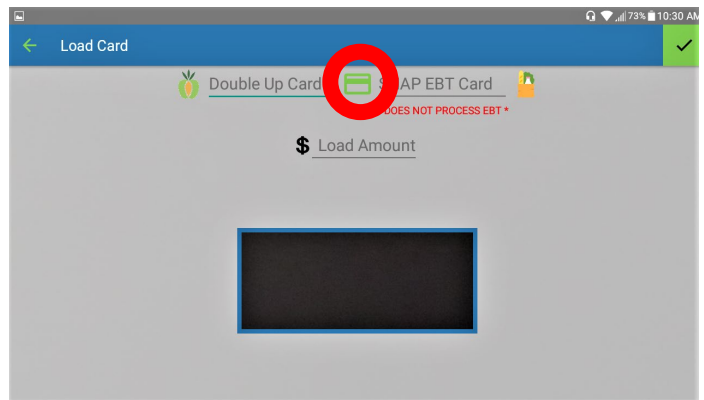
Troubleshooting

Issues with transactions:

- Ensure you are connected to wi-fi or cell service.
- Ensure the card reader is working properly. See below for card reader tips.

Card reader not responding:

- Make sure the card reader is connected & recognized.
- A GREEN ICON will indicate the card reader is connected. If the icon is grey or red, the card reader is not connected.
- If the card reader is not connected:
 1. Unplug the card reader.
 2. Turn the volume all the way up.
 3. Reinsert the card reader.
 4. The card reader indicator should now be green.



What if the card reader still won't work?

- You have 2 additional options:
 - Manually key in the card number.
 - Use the camera function to scan the card number.
- If the card reader is broken, contact your market manager.

Common error messages:

- "Invalid, Card not Found": the card is not yet linked to a shopper's account.
 - Refer customer to the market information booth.
- "EBT Already in use": the EBT # is recognized but attached to a different Fresh Bucks card.
 - Refer customer to the market information booth.

Keeping your Fresh Incentives app up to date:

1. Make sure you have a Google Play Account (Android/Samsung) or Apple App Store (iPhones/iPads) on your device set up
2. Make sure “Keep me up to date” is enabled
3. If your device typically allows for app updates automatically, there is nothing further you need to do
4. When you open your Fresh Incentive app and it prompts an update be sure to update so it runs smoothly (Recommended to check it and update the night before to avoid delays on market day)

Technical difficulties and program support:

- Contact the market manager for technical difficulties. Market managers can contact Epic Technology for app issues.
